

PROCLAMATION OF THE MAYOR OF CHAPEL HILL
CONSENTING TO APPLICATION, WITHIN THE CORPORATE LIMITS OF CHAPEL HILL,
OF THE AMENDMENT TO THE DECLARATION OF ORANGE COUNTY, NORTH CAROLINA
DATED JUNE 21, 2021, PRESERVING THE STATE OF EMERGENCY
IN ORANGE COUNTY THROUGH AND INCLUDING JULY 30, 2021,
AND ADOPTING THE AMENDMENT TO THE DECLARATION
TO MAKE IT APPLICABLE WITHIN THOSE PORTIONS OF CHAPEL HILL IN DURHAM COUNTY

WHEREAS, Orange County Board of Commissioners Chair Renée Price signed, on June 21, 2021, an Amendment to the Declaration of State of Emergency in Orange County ("Amendment to Declaration") in response to the COVID-19 Public Health Crisis, **to extend the State of Emergency in Orange County through and including July 30, 2021, unless sooner repealed**; and

WHEREAS, the declarations and the restrictions therein may be made applicable within the Town of Chapel Hill's jurisdiction with the consent of the Mayor of Chapel Hill pursuant to N.C.G.S. 166A-19.22(b)(2); and

WHEREAS, in light of data related to the impacts of COVID-19 in Orange County and Chapel Hill, the extension of the restrictions is necessary and appropriate as we strive to keep our community safe and reduce the spread of COVID-19; and

WHEREAS, a portion of the Town of Chapel Hill does not lie within the boundaries of Orange County.

NOW, THEREFORE, I, Pam Hemminger, Mayor of the Town of Chapel Hill, do hereby PROCLAIM the continued existence of a STATE OF EMERGENCY within the Town of Chapel Hill, and, pursuant to the authority granted to me by State law and Town ordinance, hereby ORDER as follows:

- a. The Orange County Amendment to Declaration dated June 21, 2021 (effective at 5:00 p.m. that day) shall apply within the Town of Chapel Hill pursuant to N.C.G.S. Sec. 166A-19.22(b)(2); and
- b. This Proclamation and its terms shall be applicable within the portions of Chapel Hill in Durham County.

This Proclamation becomes effective June 30, 2021 at 5:00 p.m. (Eastern Daylight Time) and shall remain in effect until July 30, 2021 or until rescinded or modified by further Proclamation.

A copy of this Proclamation shall be posted conspicuously on the Town website, www.townofchapelhill.org. Notice and a signed copy of this Proclamation shall be submitted to the Department of Public Safety WebEOC.
