

**PROCLAMATION OF THE MAYOR OF CHAPEL HILL  
CONSENTING TO APPLICATION, WITHIN THE CORPORATE LIMITS OF CHAPEL HILL,  
OF THE AMENDMENT TO THE DECLARATION OF ORANGE COUNTY, NORTH CAROLINA  
DATED AUGUST 10, 2021 THAT MANDATES FACE COVERINGS IN ORANGE COUNTY, AND ADOPTING  
THE AMENDMENT TO THE DECLARATION  
TO MAKE IT APPLICABLE WITHIN THOSE PORTIONS OF CHAPEL HILL IN DURHAM COUNTY**

WHEREAS, Orange County Board of Commissioners Chair Renée Price signed, on August 10, 2021, an Amendment to the Declaration of State of Emergency in Orange County ("Amendment to Declaration") in response to the COVID-19 Public Health Crisis, **to mandate the wearing of face coverings in indoor public places as set forth in that Declaration;** and

WHEREAS, the declarations and the restrictions therein may be made applicable within the Town of Chapel Hill's jurisdiction with the consent of the Mayor of Chapel Hill pursuant to N.C.G.S. 166A-19.22(b)(2); and

WHEREAS, the Mayor of Chapel Hill has consented to the Amendment to Declaration since the time of its execution; and

WHEREAS, in light of data related to the impacts of COVID-19 in Orange County and Chapel Hill, the extension of the restrictions is necessary and appropriate as we strive to keep our community safe and reduce the spread of COVID-19; and

WHEREAS, a portion of the Town of Chapel Hill does not lie within the boundaries of Orange County.

NOW, THEREFORE, I, Pam Hemminger, Mayor of the Town of Chapel Hill, do hereby acknowledge consent to the Amendment to Declaration and PROCLAIM and ORDER as follows:

- a. The Orange County Amendment to Declaration dated August 10, 2021 (effective at 5:00 p.m. August 11, 2021) applies within the Town of Chapel Hill pursuant to N.C.G.S. Sec. 166A-19.22(b)(2); and
- b. This Proclamation and its terms shall be applicable within the portions of Chapel Hill in Durham County.


**This Proclamation shall remain in effect until rescinded or modified by further Proclamation.**
